

## NEW REGISTRATION PROCEDURES FOR GRADE 1 CONTRACTORS

*Inbrief #1*  
*February 2008*

The Construction Industry Development Amendment Regulations, 2007, (see Government Notice No 1121 published in Government Gazette No 30510 of 23 November, 2007) allows unregistered contractors to apply for CIDB registration in contractor grading designation 1 in terms of a new procedure.

### 1 What is the difference between the new and old procedure?

Previously all applications for registration including those for registration in contractor grading designation 1 were sent to the **cidb** offices in Pretoria for processing. The **cidb** assessors reviewed the applications and after confirming that the supporting documents were in order and the administration fee had been received, made a recommendation to the assessment committee who took a final decision regarding registration.

This time consuming process has now changed. The **cidb** CEO has designated persons in a number of centers to register a contractor in contractor grading designation 1 if he or she is satisfied that the application satisfies all the requirements.

### 2 Where does registration take place?

Registration may take place at any of the Construction Contact Centres in Gauteng, Western Cape, Eastern Cape or KwaZulu Natal. Contractors, who come in to a CCC and have all the required documentation and proof of payment, can be registered after their information has been verified and captured on the system.

### 3 Can registration take place outside of a CCC?

Contractors can also make an application on line on [www.cidb.co.za](http://www.cidb.co.za) or simply fill an application form and post it or deliver it by hand to the **cidb** or a help desk together with the supporting documentation and proof of payment.

### 4 How much does it cost?

The contractor grading designation 1 administration fee for registering in each class of construction works is R450 for a period of three years. No annual fee is payable for contractors registered in contractor grading designation 1

Previously this administration fee was R250 and an annual fee of R200 applied.

## 5 How long is my registration valid for?

Registration will lapse after three years, unless the registration is renewed. The renewal fee for contractor registration is R450 for each class of construction works.

There is no requirement for contractor's registered in contractor grading designation 1 to submit annual update of particulars.

## 6 What supporting documentation is required?

Contractors need to bring to a CCC proof of payment into the **cidb**'s bank account of the administration fee for each and every class of construction work that a contractor applies for, as well as the following:

*Grade 1 contractors are only required to submit SARS Tax Clearance Certificates when they apply for registration or renewal of registration. They are not required to submit such a certificate every year to the **cidb***

Alternatively, a contractor may complete an application form and post the proof of payment and the required documentation with the application form to the **cidb**.

## 7 Will I be issued with a registration certificate?

Registered contractors will not be issued with a registration certificate. They will only be issued with a receipt for the payment of the administration fee which contains the contractor registration number. This needs to be kept in a safe place.

Clients may look up and confirm the contractor's registration particulars on the **cidb** website [www.cidb.org.za](http://www.cidb.org.za) using the contractor's registration number or the name under which the contractor is registered.
