1. The Protea and Hermanus Working for Water Projects have a need for clearing invading plants as detailed in the attached 4 sheets. You are invited to submit a Quotation for this work if you comply with the requirements below.
 - 1.1. You must have been **selected as one of the WfW Programme's Contractors** (The Project does consider additional Contractors from time to time. If you wish to be considered for selection as a Contractor, you should contact the Project Manager to find out when the next Contractor selection process will be held)
 - 1.2. You must have had all the necessary **training** from WfW (refer to the contractor training programme). If you are new, you may have up to 4 initial training quotes without competing against other contractors.
 - 1.3. You must have **registered** as a Contractor with WfW (supplier number, bank details, signed the WfW Rules and Regulations)
 - 1.4. If necessary, you must be registered for and show proof of payment of **VAT**. You need to register for VAT if you charge VAT and have an annual turnover of more than R1 000 000 per year. Your Clearance Certificate provides proof of payment.
 - 1.5. You must have registered for **Tax** with SARS and provide a Tax Clearance Certificate.
 - 1.6. You may not have worked n Working for Water or any other Special Public Works Programme more than **24 months in a 5 year period** (unless restarting after pregnancy)
 - 1.7. You must be from the **local area**.
 - 1.8. You may only have **one team** operating at any time.
 - 1.9. You will be required to be **on site, supervising and controlling the team, full time**. If you cannot be on site, you will be required to inform the Project Manager beforehand.

3. SUBMITTING A QUOTATION

The Quotation must be completed and signed by the Contractor, and must be deposited in a sealed envelope in **Tender Box No. 7** at the offices of the Overstrand Municipality, Magnolia Avenue, Hermanus. Quotations may only be submitted on the quotation documents supplied by the Working for Water Project Office.

The closing date and time of the quotation is on **12 October 2012 at 12H00** and will be opened immediately thereafter in the Committee Room, Hermanus Administration. No late submissions after this date will be considered.

Quotations must be valid for 60 days after the closing date. Quotations shall be evaluated in terms of the Preferential Procurement Regulations, 2011 and bidders may claim preference points in terms of their B-BBEE status level of contribution.
