### **SPECIFICATIONS:**

#### **1. Scope of work**

The successful contractor will be expected to connect new and existing septic tanks to the municipal small bore sewerage network in Voëlklip, Onrus River, Vermont and Sandbaai. A works order and plan will be issued to the contractor for the connection to or repairs to the small bore sewerage system. All works orders must be completed within 3 working days from date of issue of such work orders, weather permitting. The contractor will also be expected to clear small blockages on the small bore sewerage system.

#### **2. Contract period**

Tender validity of 60 days after closing date of tender. The Tender period will run until 30/6/2011. All rates must be fixed for the contract period.

#### **3. Acceptance criteria**

All small bore connections, installations or repairs by the contractor must be done to the satisfaction of the operational manager or his delegatee.

#### **4. Equipment**

The successful contractor will be required to have in his possession the necessary tools and equipment for the execution of the work. If not he must make arrangements to hire equipment at his own expense.

#### **5. Health and safety**

The Occupational Health and Safety Act, 1993 (Act 85 of 1993) stipulates that the Chief Executive Officer is primarily responsible or liable for the health and safety of all his/her employees. This is embedded in Section 16(1) of the said Act. This responsibility or liability is also extended to include a mandatory that performs work on behalf of the employer on his/her premises.

A “mandatory” is defined in the said Act as: - “Including an agent, contractor or subcontractor for work, but without derogating from his status in his own right as an employer or user”

In terms of Section 37(2), read with Section 41, of the said Act, it is legally possible for an employer to indemnify himself from this responsibility or liability regarding the actions of the mandatory. Section 37(2) stipulates that there should be a written agreement in place between the employer and the mandatory regarding the arrangements and procedures between them to ensure compliance by the mandatory with the provisions of the Occupational Health and Safety Act, 1993.
