1. General

Tenders are hereby invited for the **SUPPLY AND DELIVER NEW / RETREAD TYRES AND COLLECTING OF CASINGS**

2. Specifications

The following minimum requirements must be met:

- 2.1 The tender contract period will be 28 FEBRUARY 2012.
- 2.2 The tyres must comply with the SABS Code of Good Practice. Products tendered for must meet specifications as indicated as well as comply with applicable South African National Standards (SANS).
- 2.3 Tender prices must include delivery and transport costs. Delivery must be at the **MUNICIPAL WORKSHOP, MAIN ROAD, HERMANUS.**
- 2.4 Tender prices must be provided as Rand per unit.
- 2.5 Indicate in writing if the casing cannot be used.
- 2.6 Indicate percentage annual price increase (if any)
- 2.7 The successful product provider must be capable to deliver, after receipt of official order, when required:
 - 2.7.1 new tyres- within 5 working days
 - 2.7.2 retreads- within 10 working days
 - 2.7.3 call outs- within 2 hours after receiving call

3. Validity

The quote must be valid for 60(sixty) days

4. Manufacturer's Specifications

The bid documents must include a copy of the Manufacturer's manual (Marketing brochure).
The specifications stated above are the minimum requirements.

5. Warrantees & Guarantees

Bidders must provide full particulars regarding warrantees, guarantees and operating guides.
