DEFORESTATION AND CLEARING OF OVERGROWN PRIVATE ERVEN IN THE OVERSTRAND MUNICIPAL AREA (IN ACCORDANCE WITH THE OVERSTRAND MUNICIPALITY PLOT CLEARING POLICY JUNE 2007)

SPECIFICATION

Potential contractors must tender for the deforestation and clearing of private erven as set out in the conditions and requirements listed below:

A

- 1 Tender price per m² mechanically deforested, for example a bush cutter;
- 2 Tender price per m² deforested manually, for example hand tools; and
- 3 Tender price per m² for the use of specified Herbicides for the eradication and control of alien and invasive vegetation.
- 4 Tender price per m² for the removal of other undesired rubble that may be on the erf after the deforestation has been done.

The tender price will be valid for the municipality as well as the private owners for a period of **twenty four (24) months**. Tender prices for deforestation must be per square meter.

B

Potential contractors are welcome to tender for the following administration areas:

- 1 ***Kleinmond / Hangklip Area:*** Kleinmond, Betty's Bay, Pringle Bay and Rooi Els.
- 2 ***Greater Hermanus Area:*** Hermanus, Sandbaai, Vermont, Onrus, Hawston and Fisherhaven.
- 3 ***Stanford Area***
- 4 ***Gansbaai Area:*** Gansbaai, De Kelders, Kleinbaai, Franskraal and Pearly Beach.

Contractors applying for tenders must be aware of the fact that the Municipality can not guarantee the amount of erven that need to be deforested/cleared.

The tender price will be made available to the private erf owners and if the owner appoints a contractor at their will the agreement will be between the contractor and the owner.

Contractors that are awarded tenders must be prepared to conclude a Memorandum of Agreement with the Municipality to carry out the tasks instructed by the Municipality.

C

Deforestation and Clearing Requirements:

- 1 Cutting down, decreasing and removal of all surplus and undesirable alien vegetation from awarded plots.
- 2 All the material removed must be taken to the designated Municipal transfer stations or dump.
- 3 All the material removed may be cut into pieces mechanically (chipped). The maximum size of the splinters is 100 x 10mm and it may be spread over the whole area of the plot.
- 4 No garden refuse or other material may be burnt on the plot.
- 5 The topsoil may not be disturbed. It must not be left in a state that is susceptible to erosion of one or other form.
- 6 The contractor must complete the delegated tasks within 21 days of instruction.
- 7 Payment will only be approved after a final inspection has been done by a designated municipal official to ensure that the work done is in accordance with the required standard. .
- 8 Deforestation and clearing must be done with the minimum amount of disturbance to the neighboring environment and residents.
- 9 Contractors are responsible for the necessary insurance for his workers as well as for their own public liability insurance. Proof of all the insurance cover must be provided to the Municipality upon signing of the contract.

D

Potential contractors must provide a list of all equipment that they will be using for the required task of deforestation and clearing. An evaluation of such equipment will be carried out by a designated municipal official. (See list annexure A)

E

The Municipality requires references of previous similar work done by the potential contractor that must be submitted with tender documents.

Conclusion

Potential contractors must be willing to provide any additional information to the municipality on request.

NAAM VAN KWOTASIE: ONTBOSSING EN SKOONMAAK VAN OORGROEIDE PRIVAAT ERWE IN DIE OVERSTRAND MUNISIPALE GEBIED

SPESIFIKASIES

Voornemende kontrakteurs moet tender vir die ontbossing en skoonmaak van privaat erwe soos uiteengesit in die onderstaande voorwaardes en vereistes:

A

- 1 Tenderprys per m² meter meganies ontbos soos met 'n bossiekapper;
- 2 Tenderprys per m² meter per hand ontbos soos met handgereedskap;
- 3 Tenderprys per m² meter vir die gebruik van gespesifiseerde onkruidodders vir die beheer van uitheems en indringende plantegroei;
- 4 Tenderprys per m² meter vir die verwydering van addisionele ongewenste puin wat moontlik op die eiendom voorkom nadat ontbossing gedoen is.

Die tenderpryse moet geldig wees vir 'n tydperk van **vier en twintig (24) maande** vir die Munisipaliteit sowel as privaat eienaars. Tenderpryse vir ontbossing moet per m² wees.

B

Tenderaars is welkom om vir onderstaande administrasie gebiede te tender:

- 1 ***Kleinmond / Hangklip Gebied:*** Kleinmond, Bettiesbaai, Pringlebaai en Rooi Els.
- 2 ***Groter Hermanus Gebied:*** Hermanus, Sandbaai, Vermont, Onrus, Hawston en Fisherhaven.
- 3 ***Stanford Gebied***
- 4 ***Gansbaai Gebied:*** Gansbaai, De Kelders, Kleinbaai, Franskraal en Pearly Beach.

Voornemende kontrakteurs moet bewus wees dat die Munisipaliteit nie die getal erwe wat ontbos/skoongemaak moet word kan waarborg nie.

Die tenderpryse sal aan privaat erf eienaars beskikbaar gestel word en waar die eienaars besluit om self die kontrakteur aanstel sal, die ooreenkoms tussen die kontrakteur en eienaar wees.

Tenderaars moet bereid wees om met die Munisipaliteit 'n Memorandum van Ooreenkoms te sluit om die werk te doen in opdrag van die Munisipaliteit.

C

Ontbossing Vereistes:

- 1 Afmaak/vermindering en verwydering van alle oortollige, uitheems en ongewenste plantegroei van toegekende eiendomme.
- 2 Afgemaakte plantegroei moet verwyder word na aangewysde oorlaai stasies of stortingsterreine.
- 3 Afgemaakte plantegroei mag in situ versnipper word deur meganiese versnipper. Maksimum grote van splinters is 100 x 10mm en dit moet versprei word oor die oppervlakte van die perseel.
- 4 Geen afgemaakte plantegroei mag op perseel verbrand word nie.
- 5 Om erosie te vermy mag die boonste grondlaag nie onnodig versteur word nie.
- 6 Die kontrakteur moet binne 21 dae enige werksopdrag voltooi.
- 7 Betaling sal eers goedgekeur word nadat 'n finale inspeksie deur 'n aangestelde Munisipale amptenaar die werk wat gedoen is om vas te stel dat dit tot die vereiste standaard is.
- 8 Ontbossingswerk moet gedoen word met minimum steurings vir die omliggende omgewing en inwoners.
- 9 Kontrakteurs moet self alle nodige versekerings besit om sy werkers te dek asook homself te verseker vir openbare aanspreeklikheid. Bewys van alle versekering moet voor of by tekening van kontrak ingedien word.

D

Voornemende tenderaars moet 'n lys van toerusting voorsien wat gebruik gaan word om die ontbossing werk te verrig. Evaluering van die toerusting sal deur 'n aangewese amptenaar van die raad gedoen word. (sien annex A)

E

Voornemende kontrakteurs moet verwysings van vorige soortgelyk werk verrigtinge saam met die tender dokumente indien.

Afsluiting

Voornemende kontrakteurs moet bereid wees om verdere inligting aan die munisipaliteit beskikbaar te stel soos verlang word.
