

**Notice of Intent to Burn the Kleinmond Commonage – Erf 5462  
Kleinmond**



**17-21 March 2014 / 04-09 April 2014 / most suitable date thereafter.**

**Chapters 4 and 5 of the National Veld and Forest Fire Act, 1998 (Act No. 101 of 1998)**

Overstrand Municipality hereby notifies Interested and Affected Parties of the intention to burn ageing and overgrown vegetation within the Kleinmond Commonage under controlled conditions. The management area is bordered by the Kleinmond Nature Reserve to the North and West and the Kleinmond Golf Course to the East. The southern boundary constitutes 13<sup>th</sup> Avenue, 15<sup>th</sup> Avenue, 6<sup>th</sup> Street and 4<sup>th</sup> Street, Kleinmond. Ignition conditions: Prevailing S to SE wind, at 15 - 25 km/h. Vehicles, ground crews, equipment and aerial support will be under the control of the Incident Commander at the Command Centre. The programme will be adapted according to weather conditions which promote the health and safety of participants and residents. The Kleinmond Nature Reserve and Commonage Area, as well as the surrounding roads shall be a controlled and restricted access area for the duration of the programme and for 48 hours thereafter. Access shall be restricted to residents of the affected area only. Pedestrians and vehicles must ensure a safe working environment for fire response units at all times. All persons present shall be under the control of the Chief Fire Protection Officer and delegated Divisional Commanders. The decision of the Chief Fire Protection Officer is final. Please note that it is an offense in terms of Sections 25 (6) of the National Veld and Forest Fire Act, 1998 to disregard the instructions of the Chief Fire Protection Officer or designated officials. All offenders will be prosecuted.

**Hoofstukke 4 en 5 van die Nasionale Wet op Veld en Bosbrande, 1998 (Wet No. 101 van 1998)**

Hiermee stel Overstrand Munisipaliteit Belanghebbende Partye in kennis van die voorname om verouderde plantegroei binne die Kleinmond Meentgrond onder beheerde toestande te brand. Die bestuursgebied word deur die Kleinmond Natuurreervaat (noord en wes) sowel as die Kleinmond Gholfbaan (oos) afgebaken. 13de Laan, 15de Laan, 6de Straat en 4de Straat is op die suidelike grens gelêe. Brandtoestande: Oorhoofse S tot SO windrigting,

teen snelheid van 15 - 25 km/h. Alle personeelde, voertuie, toerusting en lugondersteuningsdienste sal onder die bevel van die plaaslike Incident-Bevelvoerder sorteer. Die brandprogram sal ter wille van die gesondheid en welsyn van die personeelde en die gemeenskap aangepas word. Die Kleinmond Berg- en Kus-Reservaat, die Kleimond Meentgrond, die omliggende paaie en staproetes sal as 'n beheerde en geslote gebied beskou word tydens die program sowel as 48-uur daarna. Toegang word slegs aan inwoners van die omliggende woonbuurt toegestaan. Voetgangers en voertuie moet te alle tye 'n veilige ruimte vir brandbestrydingseenhede volhou. Alle persone teenwoordig sal onder die bevel van die Hoof Brandbeskermingsbeampte- en gedelegeerde Eenheidsbevelvoerders sorteer. Die besluit van die Hoof Brandbeskermingsbeampte word as finaal beskou. Neem kennis dat dit 'n oortreding van benede Artikel 25 (6) van die Nasionale Wet op Veld en Bosbrande, 1998 is om die opdragte van die Hoof Brandbeskermingsbeampte of gedelegeerde amptenare te ignoreer. Alle oortreders sal vervolg word.
