**5. GENERAL CONDITIONS OF CONTRACT – GOVERNMENT PROCUREMENT**

**1. DEFINITIONS**

The following terms shall be interpreted as indicated:

- 1.1. "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2. "Contract" means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3. "Contract price" means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4. "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5. "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally
- 1.6. "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. "Day" means calendar day.
- 1.8. "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9. "Delivery ex stock" means immediate delivery directly from stock actually on hand
- 1.10. "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11. "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12. "Force majeure" means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable.
- 1.13. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.14. "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.15. "GCC" means the General Conditions of Contract.
- 1.16. "Goods" means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.17. "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.

- 1.18. "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.19. "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.20. "Order" means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.21. "Project site" where applicable, means the place indicated in bidding documents.
- 1.22. "Purchaser" means the organization purchasing the goods.
- 1.23. "Republic" means the Republic of South Africa.
- 1.24. "SCC" means the Special Conditions of Contract.
- 1.25. "Services" means those functional services ancillary to the supply of the goods, such as transportation and any other incidental services, such as installation, commissioning, provision of technical assistance, training, catering, gardening, security, maintenance and other such obligations of the supplier covered under the contract.
- 1.26. "Supplier" means the successful bidder who is awarded the contract to maintain and administer the required and specified service(s) to the State.
- 1.27. "Tort" means in breach of contract.
- 1.28. "Turnkey" means a procurement process where one service provider assumes total responsibility for all aspects of the project and delivers the full end product / service required by the contract.
- 1.29. "Written" or "in writing" means handwritten in ink or any form of electronic or mechanical writing.

## 2. Application

- 2.1. These general conditions are applicable to all bids, contracts and orders including bids for functional and professional services, sales, hiring, letting and the granting or acquiring of rights, but excluding immovable property, unless otherwise indicated in the bidding documents.
- 2.2. Where applicable, special conditions of contract are also laid down to cover specific supplies, services or works.
- 2.3. Where such special conditions of contract are in conflict with these general conditions, the special conditions shall apply.

## 3. General

- 3.1. Unless otherwise indicated in the bidding documents, the purchaser shall not be liable for any expense incurred in the preparation and submission of a bid. Where applicable a non-refundable fee for documents may be charged.
- 3.2. Invitations to bid are usually published in locally distributed news media and on the municipality / municipal entity website.

## 4. Standards

- 4.1. The goods supplied shall conform to the standards mentioned in the bidding documents and specifications.

## 5. Use of contract documents and information; inspection.

- 5.1. The supplier shall not, without the purchaser's prior written consent, disclose the contract, or any provision thereof, or any specification, plan, drawing, pattern, sample, or information furnished by or on behalf of the purchaser in connection therewith, to any person other than a person employed by the supplier in the performance of the contract. Disclosure to any such employed person shall be made in confidence and shall extend only as far as may be necessary for purposes of such performance.
- 5.2. The supplier shall not, without the purchaser's prior written consent, make use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract.

- 5.3. Any document, other than the contract itself mentioned in GCC clause 5.1 shall remain the property of the purchaser and shall be returned (all copies) to the purchaser on completion of the supplier's performance under the contract if so required by the purchaser.
- 5.4. The supplier shall permit the purchaser to inspect the supplier's records relating to the performance of the supplier and to have them audited by auditors appointed by the purchaser, if so required by the purchaser.

## 6. Patent rights

- 6.1. The supplier shall indemnify the purchaser against all third-party claims of infringement of patent, trademark, or industrial design rights arising from use of the goods or any part thereof by the purchaser.
- 6.2. When a supplier developed documentation / projects for the municipality / municipal entity, the intellectual, copy and patent rights or ownership of such documents or projects will vest in the municipality / municipal entity.

## 7. Performance security

- 7.1. Within thirty (30) days of receipt of the notification of contract award, the successful bidder shall furnish to the purchaser the performance security of the amount specified in SCC.
- 7.2. The proceeds of the performance security shall be payable to the purchaser as compensation for any loss resulting from the supplier's failure to complete his obligations under the contract.
- 7.3. The performance security shall be denominated in the currency of the contract or in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms:
- 7.3.1. bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or
- 7.3.2. a cashier's or certified cheque
- 7.4. The performance security will be discharged by the purchaser and returned to the supplier not later than thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified.

## 8. Inspections, tests and analyses

- 8.1. All pre-bidding testing will be for the account of the bidder.
- 8.2. If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspections tests and analysis, the bidder or contractor's premises shall be open, at all reasonable hours, for inspection by a representative of the purchaser or an organization acting on behalf of the purchaser.
- 8.3. If there are no inspection requirements indicated in the bidding documents and no mention is made in the contract, but during the contract period it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned.
- 8.4. If the inspections, tests and analyses referred to in clauses 8.2 and 8.3 show the goods to be in accordance with the contract requirements, the cost of the inspections, tests and analyses shall be defrayed by the purchaser.
- 8.5. Where the goods or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such goods or services are accepted or not, the cost in connection with these inspections, tests or analyses shall be defrayed by the supplier.
- 8.6. Supplies and services which are referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected.

- 8.7. Any contract goods may on or after delivery be inspected, tested or analyzed and may be rejected if found not to comply with the requirements of the contract. Such rejected goods shall be held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with goods which do comply with the requirements of the contract. Failing such removal the rejected goods shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute goods forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected goods, purchase such goods as may be necessary at the expense of the supplier.
- 8.8. The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract on account of a breach of the conditions thereof, or to act in terms of Clause 22 of GCC.

## 9. Packing

- 9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt and precipitation during transit, and open storage. Packing, case size and weights shall take into consideration, where appropriate, the remoteness of the goods' final destination and the absence of heavy handling facilities at all points in transit.
- 9.2. The packing, marking, and documentation within and outside the packages shall comply strictly with such special requirements as shall be expressly provided for in the contract, including additional requirements, and in any subsequent instructions ordered by the purchaser.

## 10. Delivery

Delivery of the goods shall be made by the supplier in accordance with the documents and terms specified in the contract. The details of shipping and/or other documents to be furnished by the supplier are specified.

## 11. Insurance

The goods supplied under the contract shall be fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified.

## 12. Transportation

Should a price other than an all-inclusive delivered price be required, this shall be specified.

## 13. Incidental

- 13.1. The supplier may be required to provide any or all of the following services, including additional services, if any:
- 13.1.1. performance or supervision of on-site assembly and/or commissioning of the supplied goods;
  - 13.1.2. furnishing of tools required for assembly and/or maintenance of the supplied goods;
  - 13.1.3. furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods;
  - 13.1.4. performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and
  - 13.1.5. training of the purchaser's personnel, at the supplier's plant and/or on-site, in assembly, start-up, operation, maintenance, and/or repair of the supplied goods.
- 13.2. Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.

**14. Spare parts**

- 14.1. As specified, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier:
- 14.1.1. such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and;
- 14.1.2. in the event of termination of production of the spare parts:
- 14.1.2.1. advance notification to the purchaser of the pending termination, in sufficient time to permit the purchaser to procure needed requirements; and
- 14.1.2.2. following such termination, furnishing at no cost to the purchaser, the blueprints, drawings, and specifications of the spare parts, if requested.

**15. Warranty**

- 15.1. The supplier warrants that the goods supplied under the contract are new, unused, of the most recent or current models, and that they incorporate all recent improvements in design and materials unless provided otherwise in the contract. The supplier further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.
- 15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC.
- 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.
- 15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.
- 15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights which the purchaser may have against the supplier under the contract.

**16. Payment**

- 16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified.
- 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfillment of other obligations stipulated in the contract.
- 16.3. Payments shall be made by the purchaser **no later than thirty (30) days** after submission of an **invoice, statement** or claim by the supplier.
- 16.4. Payment will be made in Rand unless otherwise stipulated.

**17. Prices**

Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized or in the purchaser's request for bid validity extension, as the case may be.

**18. Variation orders**

In cases where the estimated value of the envisaged changes in purchase does not vary more than 15% of the total value of the original contract, the contractor may be instructed to deliver the goods or render the services as such. In cases of measurable quantities, the contractor may be approached to reduce the unit price and such offers, may be accepted provided that there is no escalation in price.

**19. Assignment**

The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.

**20. Subcontracts**

The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract, if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract.

**21. Delays in the supplier's performance**

- 21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract.
- 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract.
- 21.3. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available.
- 21.4. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 22 without the application of penalties.
- 21.5. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

**22. Penalties**

Subject to GCC Clause 25, if the supplier fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.

**23. Termination for default**

- 23.1. The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, may terminate this contract in whole or in part:
  - 23.1.1. if the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2;
  - 23.1.2. if the Supplier fails to perform any other obligation(s) under the contract; or

- 23.1.3. if the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract.
- 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated.
- 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years.
- 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a time period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.
- 23.5. Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchase actively associated.
- 23.6. If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:
- 23.6.1. the name and address of the supplier and / or person restricted by the purchaser;
- 23.6.2. the date of commencement of the restriction
- 23.6.3. the period of restriction; and
- 23.6.4. the reasons for the restriction.
- These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.
- 23.7. If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.

#### 24. Anti-dumping and countervailing duties and rights

When, after the date of bid, provisional payments are required, or antidumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. When, after the said date, such a provisional payment is no longer required or any such anti-dumping or countervailing right is abolished, or where the amount of such provisional payment or any such right is reduced, any such favourable difference shall on demand be paid forthwith by the contractor to the State or the State may deduct such amounts from moneys (if any) which may otherwise be due to the contractor in regard to supplies or services which he delivered or rendered, or is to deliver or render in terms of the contract or any other contract or any other amount which may be due to him.

#### 25. Force Majeure

- 25.1. Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure.

- 25.2. If a force majeure situation arises, the supplier shall promptly notify the purchaser in writing of such condition and the cause thereof. Unless otherwise directed by the purchaser in writing, the supplier shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

## 26. Termination for insolvency

The purchaser may at any time terminate the contract by giving written notice to the supplier if the supplier becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the supplier, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

## 27. Settlement of Disputes

- 27.1. If any dispute or difference of any kind whatsoever arises between the purchaser and the supplier in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.
- 27.2. If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the supplier may give notice to the other party of his intention to commence with mediation. No mediation in respect of this matter may be commenced unless such notice is given to the other party.
- 27.3. Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.
- 27.4. Notwithstanding any reference to mediation and/or court proceedings herein,
- 27.4.1. the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and
- 27.4.2. the purchaser shall pay the supplier any monies due for goods delivered and / or services rendered according to the prescripts of the contract.

## 28. Limitation of liability

- 28.1. Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;
- 28.1.1. the supplier shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the supplier to pay penalties and/or damages to the purchaser; and
- 28.1.2. the aggregate liability of the supplier to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment

## 29. Governing language

The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.

## 30. Applicable law

The contract shall be interpreted in accordance with South African laws, unless otherwise specified.

## 31. Notices

- 31.1. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice
- 31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.

**32. Taxes and duties**

- 32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.

**33. Transfer of contracts**

The contractor shall not abandon, transfer, cede, assign or sublet a contract or part thereof without the written permission of the purchaser.

**34. Amendment of contracts**

No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.

**35. Prohibition of restrictive practices.**

- 35.1. In terms of section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, an agreement between, or concerted practice by, firms, or a decision by an association of firms, is prohibited if it is between parties in a horizontal relationship and if a bidder(s) is / are or a contractor(s) was / were involved in collusive bidding.
- 35.2. If a bidder(s) or contractor(s) based on reasonable grounds or evidence obtained by the purchaser has / have engaged in the restrictive practice referred to above, the purchaser may refer the matter to the Competition Commission for investigation and possible imposition of administrative penalties as contemplated in section 59 of the Competition Act No 89 Of 1998.
- 35.3. If a bidder(s) or contractor(s) has / have been found guilty by the Competition Commission of the restrictive practice referred to above, the purchaser may, in addition and without prejudice to any other remedy provided for, invalidate the bid(s) for such item(s) offered, and / or terminate the contract in whole or part, and / or restrict the bidder(s) or contractor(s) from conducting business with the public sector for a period not exceeding ten (10) years and / or claim damages from the bidder(s) or contractor(s) concerned.

Failure on the part of a bidder to submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed.

1.7. The Municipality reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the Municipality.

**2. DEFINITIONS**

- 2.3. *“B-BBEE status level of contributor”* means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4. *“Bid”* means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5. *“Broad-Based Black Economic Empowerment Act”* means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);

- 2.6. *“Comparative Price”* means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7. *“Consortium or Joint Venture”* means an association of persons for the purpose of combining their expertise, property, capital, efforts, skills and knowledge in an activity for the execution of a contract;
- 2.8. *“Contract”* means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9. *“EME”* means any enterprise with an annual total revenue of R5 million or less (except where Sector Charter Thresholds apply);
- 2.10. *“Firm Price”* means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11. *“Functionality”* means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12. *“Non-firm Prices”* means all prices other than “firm” prices;
- 2.13. *“Person”* includes a juristic person;
- 2.14. *“Rand Value”* means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15. *“Sub-contract”* means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16. *“Total Revenue”* bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the Government Gazette on 9 February 2007;

**INTRODUCTION**

The Occupational Health and Safety Act, 1993 (Act 85 of 1993) stipulates that the Chief Executive Officer is primarily responsible or liable for the health and safety of all his/her employees. This is embedded in Section 16(1) of the said Act. This responsibility or liability is also extended to include a mandatory that performs work on behalf of the employer on his/her premises.

A “mandatory” is defined in the said Act as: - *“Including an agent, contractor or subcontractor for work, but without derogating from his status in his own right as an employer or user”*

In terms of Section 37(2), read with Section 41, of the said Act, it is legally possible for an employer to indemnify himself from this responsibility or liability regarding the actions of the mandatory. Section 37(2) stipulates that there should be a written agreement in place between the employer and the mandatory regarding the arrangements and procedures between them to ensure compliance by the mandatory with the provisions of the Occupational Health and Safety Act, 1993.

By ensuring that there is a written agreement in place, the Management of Overstrand Municipality is acting in a responsible manner, so as to ensure that this requirement is indeed being met.

In order to ensure that this written agreement is honoured at all times, regular inspections of work that is performed will be conducted and if found not complying with the said agreement, a notice of non-compliance will be issued. All work will be stopped and reasons for non-compliance must be given and what corrective action will be taken to rectify the situation must be stipulated.

**16. SPECIFICATIONS**

**1. SCOPE OF WORK**

1.1. The Overstrand Municipality request suitably qualified contractors residing within the Gansbaai area (must have a municipal account) to provide plant, labour and materials for the period ending 30 June 2017 for the following projects –

1.2. Cleaning of:

**1.2.1. Area A:**

Masakhane Informal Settlement (demarcated area indicated on map attached as Annexure A)

**1.2.2. Area B:**

Masakhane Formal Township/Beverley Hills Informal Settlement , Blompark (demarcated areas indicated on maps attached as Annexure B & C)

**1.2.3. Area C:**

Stanford North/Tembelihle/Die Kop - Stanford (demarcated areas indicated on the maps attached as Annexure D & E)

1.3. The project requires the following work to be performed:

- 1.3.1. removal of refuse/rubble;
- 1.3.2. cutting of road verges; terrain
- 1.3.3. the sweeping of roads;
- 1.3.4. cleaning of storm-water drains and channels;
- 1.3.5. cleaning public open spaces; and
- 1.3.6. cleaning of toilets, ablution buildings and grounds of the ablution facilities.

**2. SPECIAL CONDITION**

Due to the inherent requirements of the project, with special reference to the relevant provisions of paragraph 10 below, the tenderer must reside within a radius of 5km of the specified areas wherein the work will be executed,

**3. SITE MEETING**

A Compulsory Site Meeting will be held at the Overstrand Municipal Offices, Main Road, Gansbaai, at 10H00 on Tuesday, 13 May 2014.

**4. DEFINITIONS**

4.1. In this document the word "MUNICIPALITY" shall refer to the OVERSTRAND MUNICIPALITY and the titles of officials, for example Area Manager, Assistant Area Manager, Operational Manager and Housing Officer shall refer to those employees of the MUNICIPALITY designated with those titles.

4.2. The words "I" and "We" shall refer to the CONTRACTOR.

**5. AREA OF WORK**

5.1. The Cleaning operation shall be carried out within the demarcated areas as set out in Annexures A, B, C, D and E to this specification.

5.2. The area maps of the different areas are attached:

**6. LEVELS OF CLEANLINESS**

- 6.1. Refer to the cleanliness/tidiness of the agreed area of work according to which payment to the CONTRACTOR will be effected.
- 6.2. The levels are expressed in the following percentages, namely:
  - 6.2.1. 100%,
  - 6.2.2. 75%,
  - 6.2.3. 50%,
  - 6.2.4. 25% and
  - 6.2.5. Zero for no work done since the previous evaluation.

**7. PUBLIC LIABILITY**

- 7.1. The Municipality shall not be liable in respect of any claims, damages, accidents, etc. to persons, properties, vehicle, etc. that may arise from the carrying out of this contract.
- 7.2. The Contractor shall comply with the Occupational Health and Safety Act, as well as the Policies and by-laws of the Municipality.
- 7.3. The Contractor shall be COIDA compliant before the execution of any work in terms of this agreement.

**8. EQUIPMENT**

- 8.1. All vehicles, equipment and tools, as well as consumables required to execute the cleaning and removal operations, as per this specification, shall be provided by the contractor.
- 8.2. Proof of the existence and condition of such vehicles, equipment and tools shall be provided by the Contractor and be made available for scrutiny by the Municipality, prior to acceptance of the bid from the Contractor.
- 8.3. Further, such vehicles, equipment and tools shall be inspected by the Municipality before the signing of the Contract, as well as at any time during the term of the Contract.
- 8.4. A **monthly** report of the equipment will be required from the Contractor to be submitted to the dedicated official (housing official) which will be confirmation that equipment is safe and in a usable state.
- 8.5. At the beginning of each financial year the contractor will submit a road worthy certificate of vehicles used in the project.

**9. MATERIALS**

- 9.1. All cleaning detergents to clean toilets (for example liquid soap, toilet bowl disinfectant like Jeyes fluid) and refuse bags must be provided by the contractor.
- 9.2. Herbicides will be provided by the Municipality as and when required.

**10. CLEANING OF AREAS A, B, C, D AND E**

- 10.1. **Cleaning of all residential areas (formal and informal):**
  - 10.1.1. Collection of refuse and all forms of rubble (building materials, loose stones etc.) in the areas of informal as well as formal houses, open spaces and roads, and removal and transportation of such collected materials to dump sites allocated by the Municipality.
  - 10.1.2. Cleaning of bins in informal settlements

**10.2. Cleaning of public open spaces, play parks and roads**

- 10.2.1. Collection of refuse, all forms of rubble, as well as cutting of alien and unwanted vegetation, with machines or by hand, up to boundary fences of erven, within the demarcated areas. Further to remove such collected materials and transport to dump sites allocated by the Municipality.
- 10.2.2. Sweeping of surfaced roads and sidewalks
- 10.2.3. Cutting of unwanted vegetation, with machines or by hand, on sidewalks and removal of such materials and transported to dump sites allocated by the Municipality.
- 10.2.4. It is expected of the successful contractor(s) to report illegal dumping to the Municipality’s help desk in order to keep areas clean.

**10.3. Cleaning of open storm-water channels and kerbs, catch pits and manholes**

- 10.3.1. Removal of refuse, loose stones and any other obstacles that may affect the flow of water in the storm water drainage system.
- 10.3.2. Spraying growth in trenches with herbicides and removal of dead plant matter, rubble and silt.
- 10.3.3. The use of chemicals, herbicides or any other poisonous product is expressly prohibited without consultation with the relevant environmental section of the municipality.

**PLEASE NOTE:** This does not include the cleaning of closed-off storm-water systems pipes, culverts and removal of dead plant matter.

**10.4. Cleaning of Ablution Facilities**

- 10.4.1. The successful tenderer must appoint dedicated personnel (a minimum of two) for the ablution facilities in the Informal Settlement who must be available at the toilet blocks, from 07H45 until 16H30, 5 days a week (Monday to Friday).
- 10.4.2. 10.4.2 The toilets must be inspected on a daily basis during the week (Monday to Friday) by the Contractor who shall report on maintenance problems and on an hourly basis on public holidays and weekends by the Contractor who shall report on maintenance problems.
- 10.4.3. 10.4.3 The toilets will be inspected on a weekly basis by an Overstrand municipal Official.
- 10.4.4. 10.4.4 The inspector’s decision on the cleanliness of the facilities will be final and binding.
- 10.4.5. 10.4.5 If the site is not cleaned to the inspector’s satisfaction, a week’s payment will be deducted.
- 10.4.6. 10.4.6 Should this happen a second time, the contract will be terminated.
- 10.4.7. 10.4.7 The amount supplied will be determined after the quotation has been awarded.
- 10.4.8. 10.4.8 Overstrand Municipality will determine a minimum manpower level and cost structure per toilet block.
- 10.4.9. 10.4.9 Any quotation failing to meet these criteria will not be considered for evaluation.

**10.5. Description of Work**

- 10.5.1. Floors and walls in and around toilets must be hosed and cleaned on a daily basis.
- 10.5.2. Toilet bowls must be cleaned (brushed).

- 10.5.3. Wash basins must be cleaned (brushed).
- 10.5.4. Broken and defective toilets must be reported daily at the following telephone number: 028 384 8300.
- 10.5.5. Blocked wash basins and sewerage blockages must be reported daily at the following telephone number: 028-384 8300.
- 10.5.6. Cleaning materials: disinfectant, brooms, black bags, etc. for points a, b and c above, will be for the account of the successful tenderer.
- 10.5.7. An area with a radius of **2 metres** around the toilets is to be cleaned daily. This includes plastic, bottles, paper and glass.
- 10.5.8. Refuse is to be collected into black bags (to be supplied by the successful tenderer) and deposited into the nearest swing bin.

**11. TRANSPORT OF REFUSE ALL AREAS**

- 11.1. The Contractor shall transport all collected refuse, loose stones and rubble on appropriate vehicles to the local transfer station.
- 11.2. The dumping of collected materials by the Contractor at the local transfer station will be allowed free of charge.

**12. REPORTING OF PROBLEMS**

- 12.1. The Contractor shall list all required maintenance issues with regard to signage, potholes, and storm water and sewer blockages.
- 12.2. Such list of problems must, on a daily basis, be reported to the helpdesk at the office of the Municipality.
- 12.3. The Contractor shall report all illegal dumping of refuse or rubble in the area of employment. Such reports shall immediately been forwarded to the help desk of the Municipality.

**13. INSPECTIONS BY OVERSTRAND MUNICIPAL OFFICIALS**

- 13.1. All areas included in the specifications and Annexures A, B, C, D and E of this tender document will be inspected by an Overstrand municipal Official on regular intervals which will be determined at onset of the contract.

**14. CLEANING / ENVIRONMENTAL EDUCATION**

- 14.1. It will be expected of the Contractor to participate in Cleaning / Environmental education in proposed programmes within the agreed area of work on request of the municipality at no cost to the Contractor.
- 14.2. The Contractor, as well as his employees and agents shall be educated regarding the difference between unwanted, alien and desirable plants from time to time.

**15. PRICING SCHEDULE**

- 15.1. Bidders shall calculate the bid amount, taking into account all possible expenditures as well as adhere, to the requirements, of the sectoral wage determination, specifically regarding the minimum wage contemplated

**16. INFORMATION TO BE SUBMITTED**

- 16.1. Prospective tenderers **must** submit the following with the tender, in order for the tender to be evaluated.
- 16.2. Failure to provide this information will result in the tenderer being disqualified.
- 16.3. The bidder shall submit proof that he owns an appropriate, roadworthy vehicle to transport materials, or at least have a rental agreement in place with an entity that has such, required vehicle, and is willing to rent such vehicle to the bidder.
- 16.4. In both the above instances the following proof applies: Registration papers, last date of roadworthy certification, type of vehicle and its condition as well as proof of a valid license. An annual roadworthy certificate must be submitted.
- 16.5. The bidder must submit proof of residence within the designated cleaning area. Such proof shall be in the form of either one of the following:
  - 16.5.1. Municipal account in the name of the bidder; or
  - 16.5.2. Lease agreement with the bidder as the lessee; or
  - 16.5.3. Sworn affidavit – in the case of an informal settlement resident.
- 16.6. **The pricing schedule must be duly completed** –no opens spaces may be left on the document. If a certain item is included in another item or will be provided free of charge, it must be indicated as such in the space provided.
- 16.7. The bidder must provide a list of names and addresses of prospective employees to be employed by him/her as well as copies of their Identity documents. These prospective employees must be residing in the designated area and may not be employed elsewhere for the duration of the contract.

**17. PAYMENT**

- 17.1. The successful contractor shall invoice the Municipality on a two (2) weekly (fortnightly) basis. Payment will be made no later than 7 days after submission of invoice subject to the invoice being duly authorized and submitted to the expenditure section on a Friday.
- 17.2. Payment is based on the level of cleanliness/tidiness of the agreed area of work, which level is, subject to clause 1 (b), in the sole discretion of the Municipality.
- 17.3. The housing official shall make a recommendation to the Area Manager regarding the amount due to the Contractor.
- 17.4. The maximum weekly payment shall be in accordance with the total weekly amount set out in the pricing schedule submitted by the bidder.
- 17.5. The level of cleanliness shall be determined by the designated official (housing official) of the Municipality, the housing official shall be responsible for weekly inspections of the area, in consultation with the Area Manager.
- 17.6. After delivery of each invoice, the Contractor shall provide the Municipality with a detailed plan of its activities for the next two weeks.
- 17.7. A works program must be submitted every 2 weeks by the contractor to the Housing Official.
- 17.8. The Contractor shall submit a completed checklist (example attached), on a weekly basis, of activities and operations of the preceding period.
- 17.9. Payment terms following new classifications:
- 17.10. It is the policy of the Overstrand Municipality to pay all creditors by means of direct bank transfers, The norm is that creditors are paid after 30 days, in order to qualify for a weekly payment, a supplier must be classified as a Survivalist enterprise / Micro-enterprises on

the Municipality’s supplier database. A weekly payment is not a right in terms of this policy. Survivalist enterprises / Micro-enterprises may request such payments which may be made at the discretion of the Municipality and will terminate after 12 months, as it is expected that the enterprise will be self-sustainable thereafter. It is the obligation of the supplier to arrange earlier payments with the creditors department (Mireille Lewis – 0283138024).

- 17.11. To ensure clear understanding of the abovementioned terms, the following definitions are included:
- 17.12. **Survivalist enterprises** are generally defined as businesses set up by people unable to find a paid job or get into an economic sector of their choice. Income generated from these activities usually falls far short of even a minimum income standard, with little capital invested, virtually no skills training in the particular field and only limited opportunities for growth into a viable business. This category is characterized by poverty and the attempt to survive.
- 17.13. **Micro-enterprises** are very small businesses, often involving only the owner, some family members and at the most one or two paid employees. They usually lack 'formality' in terms of business licenses, value-added tax (VAT) registration, formal business premises, operating permits and accounting procedures. Most of them have a limited capital base and only rudimentary technical or business skills among their operators. However, many micro-enterprises advance into viable small businesses. Earning levels of micro-enterprises differ widely, depending on the particular sector, the growth phase of the business and access to relevant support.

**18. ESCALATION**

Escalation of 6% will be applied to all tendered rates on 1 July of every year from 1 July 2015 for the duration of the contract.

**19. TERMINATION OF CONTRACT**

- 19.1. The Municipality may terminate the contract at its own discretion, with immediate effect with regard to continuous poor performance (in other words below 100%) and / or for non-performance or for any reason that renders the Contractor unable to fulfil its obligations.
- 19.2. The CONTRACTOR may terminate the agreement with one (1) months written notice to the representative of the Municipality understanding that in this event, the Municipality reserves the right to appoint any other Contractor to supply the contemplated services and to claim any losses, damages or costs, of whatever nature, incurred by the Municipality due to this event.
- 19.3. Also refer to paragraph 21 to 25 of the General Condition of Contract (GCC) regarding performance and termination terms.

**20. CONTRACT PERIOD**

This contract validity period is three (3) years from the date of appointment until 30 June 2017, unless terminated in terms of paragraph 19 of this contract.

**21. TENDER VALIDITY**

Tenders must be valid for 60 days after closing date of tender.
